# HOSTING AGREEMENT

AGREEMENT is effective \_\_\_\_\_ (day) of \_\_\_\_\_ (month), 20\_\_\_\_, between burnham richards advertising llc dba Bring (hereafter referred to as BRING and \_\_\_\_\_ (hereafter referred to as CLIENT).

Subject to the terms and conditions of the Agreement, BRING will provide web hosting and maintenance services for CLIENT subject to the following terms:

## LENGTH OF SERVICE

CLIENT agrees to a minimum (12) month contractual term of service (“Term”). The length of contract required is based on the type of service desired by CLIENT and shall be determined solely by BRING.

## SERVICE START DATE

The first payment, plus setup charges if any, shall be due in advance of any service provided. Service shall begin upon BRING receipt of payment for such first Term of service or upon installation of test site.

## CONTRACT RENEWAL

This Agreement will automatically renew for successive twelve (12) month terms, unless canceled in writing by CLIENT at least 90 days prior to the end of the term renewal date. Renewal prices are subject to change. Renewal of services by CLIENT indicates agreement to any Contract revisions and process changes. Renewal fees for the following terms will be automatically invoiced to CLIENT.

## TERMS OF BILLING & PAYMENT

CLIENT will be billed quarterly or annually, or CLIENT may select automatic (EFT) transfer, and payment will be made on date indicated. The selection of the option is at the discretion of the CLIENT, and is indicated on the front page of this agreement. Terms of payment are based on net 30 upon receipt of invoice. Discounts, if offered, will be revoked if payment is not received by terms outlined in invoice. If payment is 30-days past due, BRING reserves the right to suspend hosting (website becomes inaccessible) until payment is received. CLIENT will be charged a fee to resume hosting.

## WEBSITE MAINTENANCE

Our website maintenance packages include: monitoring site, regularly scheduled updates of hosting and plugin software as well as fixing bugs or issues with existing content only. BRING will charge for creating and adding new content or features to the site, including new pages, forms or plugins. This includes fixing content uploaded by the client or another third party. An estimate of time/costs will be provided to the client prior to execution.

## CENSORSHIP

BRING will exercise no control whatsoever over the content of the information passing through the network, email or website. All authorization and responsibility of content lies with the CLIENT.

## PRIVACY POLICY

As best practices, we recommend that our clients add a privacy policy to their website(s). This privacy policy will explain the level of personal data that is being collected and how it is being used. It will also explain collection of data via forms, emails, cookies and third party data collection. (eg: logins with Google or Facebook accounts) BRING accepts no liability for breach of privacy policy or client use of any data.

## WARRANTIES

BRING makes no warranties or representations of any kind, whether expressed or implied for the service it is providing. BRING also disclaims any warranty of merchantability and will not be responsible for any damages that may be suffered by CLIENT, including loss of data resulting from delays, non-deliveries or services interruptions by any cause or errors or omissions of CLIENT. BRING hosts with a 3rd party service and utilizes 3rd party plugin features within the website. While the BRING maintains this hosting and these plugins for CLIENT purposes, BRING cannot be held responsible for 3rd party service failure.

BRING is not responsible for accuracy of site content after original date of site launch as CLIENT or other parties may has access to update content. Connection speed represents the speed of an end-to-end connection. BRING does not represent guarantees of speed or availability of end-to-end connections.

## TRADEMARKS AND COPYRIGHTED MATERIAL

CLIENT warrants that it has the right to use any applicable trademarks or copyrighted materials used in connection with this service. BRING is not held liable for website content, provided by CLIENT, that infringes on any 3rd party's copyright protection.

## TERMINATION

BRING may terminate this Agreement at its sole discretion upon the occurrence of one or more of the following events: 1) failure to comply with any provisions of the Agreement upon receipt of written notice from BRING of said failure, 2) appointment of Receiver or upon the filing of any application by CLIENT seeking relief from creditors, 3) upon mutual agreement in writing of BRING and CLIENT. Upon contract termination by CLIENT or BRING, CLIENT shall have 30 days to transfer web content to new hosting company. All content and plugins shall remain on the website, but shall no longer be renewed or updated by BRING. BRING accepts no liability for site performance after date of transfer.
